



Vacancy Announcement

The Permanent Mission of Thailand to the World Trade Organization and the World Intellectual Property Organization in Geneva is seeking eligible and qualified applicants for the position of Driver. Details are as follows:

<u>Position:</u>	Driver
<u>Closing date of application:</u>	17 July 2026
<u>Duration:</u>	Full-time, starting from 1 October 2026 or at the earliest
<u>Salary:</u>	CHF 3,393 per month, with possible bonus, overtime pay and other applicable benefits

Probation period and performance appraisal:

There will be a three-month probation period. After that, during the employment period, a performance appraisal will be conducted annually. Should the performance not be satisfactory, the Permanent Mission may, at its discretion, take measures including terminating the employment.

Job Description:

1. Driving a vehicle for various official duties including the transportation/delivery of documents, parcels and passengers or other tasks as assigned.
2. Monitoring usage, condition and maintenance as well as preliminary fixing technical problems to ensure that the vehicles are in a clean, safe and ready-to-use condition at all times. Notifying and advising on maintenance of the vehicles.
3. Assisting and supporting the Ambassador and other officials including in performing various tasks and organizing activities of the mission, as assigned.

Qualifications Required:

1. At least 25 years of age.
2. Clean criminal record. Extraordinary driving record.
3. Good health. A level of fitness for a professional driver.
4. Must have valid government-issued documents authorizing employment in Switzerland if not holding Swiss Nationality.
5. Must hold a valid Swiss driver license or an equivalent license recognized in Switzerland. Must be legally authorized to drive both passenger cars and vans in Switzerland and neighbouring countries.

6. Professional working proficiency in English. Proficiency in Thai and/or French will be an advantage.

7. Must have extensive driving experience in the Canton of Geneva and surrounding areas, with excellent knowledge of local roads, routes, and key landmarks. Experience driving for executives is an advantage.

8. Must be proficient in using GPS and navigation tools and be able to communicate effectively and efficiently with office staff using appropriate digital communication platforms.

9. Good knowledge of vehicles mechanics and their maintenance.

10. Extraordinary knowledge of and adherence to traffic regulations, as well as road disciplines and practices of Switzerland and its surroundings.

11. Service mind, professionalism, ability and readiness to complete assigned tasks in time, maturity, ability to work well as a team.

12. Flexibility to work outside official working hours including on holidays. Ability and readiness to support various tasks/activities of the mission.
